Dedication Set for August 23rd!



The new center is attached to the Trinity Elementary building which is located next to Sacred Heart church at 312 S. 4th street. St. Mary's Challenge Helps Prince of Peace

avid McAndrews, St. Mary's High School alumnus from the Class of 1957, issued a St.

Mary's Challenge to his fellow classmates of 1957-1960 in January of 1998. The goal was to raise \$25,000 for the new education center. In April, the goal was surpassed!

McAndrews agreed to match responses dollar for dollar up to a maximum of \$25,000 for the Capital Campaign for the new Prince of Peace Parish education center. The facility would replace the Mater Dei High School and former St. Mary's grade school buildings. Responses totaling \$27,125 were achieved in April. Currently, campaign responses for the classes of 1957-1960 total \$77,550. A plaque commemorating the classes' achievement will be included in the new education center.

Benefits Will Be Substantial

hy a Multi-purpose Center?

The new education center has been referred to as a "multi-purpose" education center. The reason behind the term "multi-purpose" is because the facility will be used for more than K-12 Catholic school.

Besides day-time Catholic School classes, the center will be used for a wide range of activities on evenings and weekends. Such activities will include:

- religious education classes for students in public school,
- family religious education programs,
- adult discussion/education groups,
- Parish youth group activities,
- woman's auxiliary,
- School Board and Parish Council,
- Alumni Association, Booster Club, Girl and Boy Scouts, Knights of Columbus, etc.

The new center will be able to accommodate these diverse organizations and functions, along with a K-12 Catholic school. Best of all, it can be accomplished economically, efficiently and effectively at one site!

What a huge difference this will make! Just consider the fact that over the past years, functions had to be held at seven different buildings spread throughout the city at five Parish property sites. The new education center symbolizes the progress and forethought necessary for building a brighter future!



New Pledge of \$100,000 Received!

n additional gift of \$100,000 has been pledged toward the *Building the Future Together* Capital Campaign, boosting the campaign to 95 % of its \$3.1 million goal. The donor, who wished no recognition for the generous gift, expressed the desire to contribute to the education center's success and further the goals of Prince of Peace Parish.

"This is a tremendous gift from a wonderful person, and the timing was perfect!" stated Development Director David Schnier. "The gift will allow us to acquire upgraded classroom furniture and equipment for the center. It came at a perfect time because the Master Plan committee was needing to place an order soon to have the supplies by Fall for the 1998-1999 school year.

A total of \$2,958,520 has been pledged so far to the five-year Capital Campaign, with over \$820,000 already paid to date.

Thanks to the hundreds and hundreds of supporters including alumni, area businesses, corporations, foundations and members of Prince of Peace who have supported the campaign with their time, talent and treasure.

Grants are Vital to Affordable Catholic Education

rants from the Prince of Peace School Foundation and the Regina Gill Trust amounting to over \$23,500 were awarded for "Guardian Angel" scholarships and tuition assistance for the 1998-1999 school year. In 1996, the Foundation received a gracious bequest of \$218,000 from the Margaret Judge estate. The Margaret Judge gift is invested and the interest generated from the endowment will provide tuition assistance to families and students requiring financial aid for years to come.

The Prince of Peace School Foundation Memorial Scholarship Funds also included the John Lingle scholarship \$1,000, the Lyman and Ullainee Wareham Memorial \$500, and \$12,000 for general tuition assistance grants. Where There is a Will . . .


id you know that it is estimated that 80% of the population who are not college graduates do not have wills, and of college graduates, 60% do not have wills. Do you have a will? Is it current?


